- c. Encourage teachers and students to study and exchange with each other, and canjointly develop bachelor/master/doctorate programs;
- d. To carry out cultural exchanges and study visits, both parties should reach and sign a written memorandum before the project starts.

2. 合作领域

- 3.1 If there is a difference between the interpretation of this memorandum by both parties, it shall be resolved through friendly negotiation.

- 4. Validity of the MOU

The MoU becomes effective on the date of signing and will remain in effect from 2024/10/24 to 2029/10/23 (yy/mm/dd)

This Memorandum of Understanding is signed by Phetchabun Rajabhat University and Yunnan College of Finance and Economics. Both parties hope to sign this memorandum of understanding to declare their respective intentions and in accordance with the terms contained in the memorandum. The relationship between the two parties to establish cooperation and collaboration is as follows:

1. Cooperation goals

To achieve the common goals of both parties, develop and implement the cooperation items setting forth in the cooperation field.

2. Cooperation areas

The MOU between Phetchabun Rajabhat University and Yunnan College of Finance and Economics shall be fulfilled through the following activities or programs, including but not limited to:

- a. Strengthen information exchange in academic activities of mutual interest;
 - b. Promote appropriatejoint academic activities;

Either party can suspend cooperation during the validity period of this memorandum, but must provide the other party with written notice three months in advance.

When the two parties did not follow this memorandum or the ongoing achievements, academics or activities did not comply with the memorandum requirements. Terminate the cooperation between the two parties in education quality assurance.

If any party wishes to extend the time limit of this memorandum within the duration specified in the memorandum. Both parties must notify each other in writing at least 3 months in advance.

Either party can send a written notice to the other party at least 3 months before the expiration of this memorandum, indicating its intention to renew the memorandum, and it can only be renewed after both parties agreed in writing.

4. 谅解备忘录的有效期

谅解备忘录自签署之日起生效,有效期为2024年10月24日起至2029年10月23日止。任何一方均可在本备忘录有效期内中止合作,但必须提前三个月书面通知对方。当双方不遵守本备忘录或正在取得的成果、学术或活动不符合备忘录的要求时。终止双方在教育质量保证方面的合作。如果任何一方希望在备忘录规定的期限内延长本备忘录的期限。双方必须至少提前3个月书面通知对方。任何一方均可在本备忘录期满前至少3个月向另一方发出书面通知,表明其续签备忘录的意向,只有经双方书面同意后方可续签。

- 5. Revision, change and amendment
- 5. 1 Any party can propose revision, changes or revision to this MOU in writing.
- 5.2 Such revision, changes or amendment shall take effect on the date determined by both parties.
- 5.3 Any revision, change or amendment shall not damage any project, activity or cooperation based on this MOU that has been implemented before or after the date of this revision, change or amendment.
- 5.4 This memorandum of cooperation is written in Chinese and English, and both versions have the same legal effect. The two versions must be consistent. In case of any discrepancy, the Chinese version shall prevail.
- 5.5 In case of any dispute arising from the cooperation between the parties, the dispute shall be settled in accordance with the laws of the People's Republic of China.
- 5.6 This memorandum of cooperation shall come into force as of the date when the legal representatives or authorized agents of the parties sign and affix their official seals or special contract seals respectively. It is made in [2]. Party A holds [1] copy and Party B holds [1] copy.
